STATEMENT OF THE CASE

COG seeks an order (1) creating a 120-acre spacing and proration unit comprised of the S/2SW/4 and the SW/4SE/4 of Section 15, Township 18 South, Range 26 East, NMPM, Eddy County, New Mexico; (2) pooling all mineral interests underlying this acreage from the top of the Yeso formation to a depth of 4,000 feet; and (3) approving a non-standard 120-acre project area. COG proposes to dedicate the above-referenced spacing and proration unit as the project area for its proposed Pilum 15 Fee 2H Well, which will be horizontally drilled from a surface location in the SE/4SE/4 (Unit P) of

Section 16, Township 18 South, Range 26 East to a standard bottom hole location in SW/4SE/4 (Unit O) of Section 15. The completed interval for this well will commence in SW/4SW/4 (Unit M) of Section 15 and remain within the 330-foot standard offset required by the Statewide Rules set forth in 19.15.15 NMAC.
