APPLICATION OF MEWBOURNE OIL COMPANY FOR A NON-STANDARD OIL SPACING AND PRORATION UNIT AND COMPULSORY POOLING, EDDY COUNTY, NEW MEXICO.

APPLICATION

Mewbourne Oil Company applies for an order (i) approving a non-standard oil spacing and proration unit in the Bone Spring formation comprised of the W½E½ of Section 22 and the W½E½ of Section 27, Township 26 South. Range 27 East, N.M.P.M., Eddy County, New Mexico, and (ii) pooling all mineral interests in the Bone Spring formation underlying the nonstandard unit, and in support thereof, states:

1. Applicant is an interest owner in the $W_{2}E_{2}$ of Section 22 and the $W_{2}E_{2}$ of Section 27, and has the right to drill a well thereon.

2. Applicant proposes to drill its Owl Draw 22/27 B2BO Fed. Com. Well No. 2H to a depth sufficient to test the Bone Spring formation. Applicant seeks to dedicate the W_2E_2 of Section 22 and the W_2E_2 of Section 27 to the well to form a non-standard 320 acre oil spacing and proration unit (project area), for all pools or formations developed on 40 acre spacing. The well is a horizontal well, with a surface location 330 feet from the north line and 1585 feet from the east line of Section 22, and a terminus 330 feet from the south line and 1980 feet from the east line of Section 27.

3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the $W_{2}E_{2}$ of Section 22 and the $W_{2}E_{2}$ of Section 27 for the purposes set forth herein.

4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests. Therefore, applicant seeks an order pooling all mineral interest owners in the W½E½ of Section 27, pursuant to NMSA 1978 §§70-2-17, 18.

5. Approval of the non-standard unit and the pooling of all mineral interests underlying the $W^{1}_{2}E^{1}_{2}$ of Section 22 and the $W^{1}_{2}E^{1}_{2}$ of Section 27 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

A. Approving a non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the $W_{2}E_{2}^{\prime}$ of Section 22 and the $W_{2}E_{2}^{\prime}$ of Section 27;

B. Pooling all mineral interests in the Bone Spring formation underlying the $W_{2}E_{2}^{\prime}$ of Section 22 and the $W_{2}^{\prime}E_{2}^{\prime}$ of Section 27;

C. Designating applicant as operator of the well;

D. Considering the cost of drilling and completing the well, and allocating the cost among the well's working interest owners;

E. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and

F. Setting a 200% charge for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well.

Application of Mewbourne Oil Company for a non-standard oil spacing and proration unit and compulsory pooling, Eddy County, New Mexico. Mewbourne Oil Company seeks an order approving a 320-acre non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the W/2E/2 of Section 22 and the W/2E/2 of Section 27, Township 26 South, Range 27 East, NMPM. Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the non-standard unit for all pools or formations developed on 40 acre spacing within that vertical extent. The unit is to be dedicated to the Owl Draw 22/27 B2BO Fed. Com. Well No. 2H, a horizontal well with a surface location 330 feet from the north line and 1585 feet from the east line of Section 27.
