Case No. 14979 (Re-opened)

APPLICATION

Mesquite SWD, Inc. applies to re-open Case No. 14979 to amend Order No. R-13735 to allow a new well and new well location for a salt water disposal well, and in support thereof, states:

1. Order No. R-13735, entered in Case No. 14979, granted applicant permission to drill its Paduca Fed. SWD Well No. 3, to be located 300 feet from the north line and 1760 feet from the west line of Section 23, Township 25 South, Range 32 East, N.M.P.M., Lea County, New Mexico, and dispose of produced water into the Bell Canyon and Cherry Canyon members of the Delaware formation at depths of 4870-7250 feet subsurface.


2. Due to well problems, the Paduca Fed. SWD Well No. 3 was abandoned.

3. Applicant seeks an order amending Order No. R-13735 to allow disposal into the substitute Paduca Fed. SWD Well No. 3Y (API No. 30-025-42258), located 310 feet from the north line and 1760 feet from the west line of Section 23, Township 25 South, Range 32 East, NMPM.

4. The granting of this application will prevent waste and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order approving this application.
