Gentlemen: Since this Case was filed at the end of September, WPX has been diligently working with the BLM and the interest owners to finalize the unit boundary and execute the necessary agreements. This has resulted in three continuances. WPX would like to request one last 60-day continuance before either proceeding or dismissing the Application. The problem with dismissal and refiling is the extensive notice cost (almost \$15,000) and coordination of same.

No other party has appeared in this matter and WPX has been in touch with FIMO and the Allottees (to the extent possible) about the status of this application. We therefore request that this matter be continued one last time to the March 19th docket with the understanding that by that time WPX will either dismiss and refile, or proceed with the current application.
