This letter is to advise you that COG Operating LLC has filed the enclosed application with the New Mexico Oil Conservation Division. You are receiving notice of this application because of the request for the proposed unorthodox well location.

WPX Energy Production, LLC proposes to drill the **Chaco 2408-33D 113H Well** from a surface location 1304 feet from the North Line and 372 feet from the West line (Unit D) of Section 33. The completed interval will be at an unorthodox location for this horizontal, and will commence 380 feet from the West line and 1598 feet from the North line (Unit E) to a location 330 feet from the East line and 2400 feet from the North line (Unit H) of Section 33.

This application has been set for hearing before a Division Examiner at 8:15 AM on January 22, 2014. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505.
