3 will go ahead to Case 15245, application of MRC Permian
4 Company for compulsory pooling and approval of an
5 unorthodox gas well location.

6 Call for appearances.

7 MR. BRUCE: Mr. Examiner, Jim Bruce of
8 Santa Fe representing the Applicant. I just have a
9 brief statement and notice exhibits to submit.

10 My brief statement is that yesterday I was
11 told that MRC Permian has reached agreement with all of
12 the interest owners and forced pooling is no longer
13 required.

14 EXAMINER GOETZE: Congratulations
15 (laughter).

16 MR. BRUCE: It only took four months.

17 The only thing left is -- and this is a
18 Wolfcamp well, and it's an unorthodox location request.
19 And I submit the Affidavit of Notice because there was
20 one offset, Plantation Operating, LLC, which disappeared
21 somewhere along the line, so notice was published as
22 against them.

23 I'd move the admission of Exhibit 12 and
24 ask that the matter be taken under advisement for the
25 unorthodox location portion.

1 EXAMINER GOETZE: So in Case 15245, Exhibit
2 Number 12 is so accepted.

3 As requested by counsel, the compulsory
4 pooling request shall be dropped from the application.

5 Case 15245 is taken under advisement.

6 Thank you.

7 (MRC Permian Company Exhibit Number 12 was
8 offered and admitted into evidence.)


