2 EXAMINER JONES: Let's go on the record this
3 morning. This is the Examiner Hearing for April 16th,
4 2015, Docket No. 11-15. I am William V. Jones, hearing
5 examiner today. Allison Marks is legal counsel for the
6 Division today. She is sitting to my left.

7 First let's call continuances and
8 dismissals. There is one case that is not on this
9 docket and I need to let you know that that case, No.
10 1527(A) is continued to April 30th instead of May
11 the 14th like previously noted.

12 And on page 1, Case 15266 is dismissed.
13 Case 15267 is continued to May the 28th. Case 15285 is
14 continued to April 30th. And on page 2, Case 15274 is
15 continued to April 30th. Case 15287 is dismissed.

16 Page 3, Case 15265 is continued to
17 April 30th. Case 15290 is continued to May the 14th.
18 And, on page 4, Case 15263 is continued to May the 14th.
19 Case 15280 is continued to May 28th.

20 Any corrections, any other continuances or
21 dismissals?

22 MR. FELDEWERT: Mr. Examiner --

23 THE REPORTER: Please identify yourself for
24 the record.

25 MR. FELDEWERT: Mr. Examiner, Michael

1 Feldewert with the Santa Fe Office of Holland & Hart.

2 On page 2, at the bottom, Case 15288, and,
3 then, the next page, the next EOG case, Case 15289, we
4 ask that those be continued until April 30th.

5 And then, staying on page 3, Case 15276,
6 Application COG -- we've -- as it notes, that case is
7 being continued until April 30th. I think that's in the
8 heading there for 15276.

9 EXAMINER JONES: Thank you, Mr. Feldewert.

10 I saw that note it was continued. So we are
11 going to continue Case 15276 to April 30th. And Case
12 15288 and Case 15289 are continued to April 30th.

13 Any other changes, continuances, or
14 dismissals?

15 MR. FELDEWERT: And one other note,
16 Mr. Examiner, if I may check with counsel and, if I
17 could, I have Case 15281 on page 3, and, then, the next
18 two cases, 15282 and 15283, on page 4; those are just
19 simply being called to address a notice issue. If I
20 could take that out of order, I would appreciate it,
21 because those are the only two cases I have here.

22 EXAMINER JONES: Okay. Let's do that.
23 Let's call first Case 15281. Do you want to call the
24 three cases together?

25 MR. FELDEWERT: Rather -- we could call them

1 separately -- the next two cases we could call together
2 because they were consolidated for a hearing.
