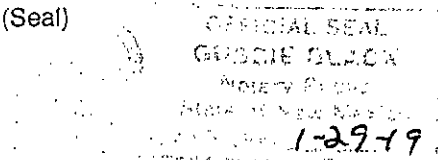

CASE 15327: Application of COG Operating LLC for a non-standard spacing and proration unit and compulsory pooling, Lea County, New Mexico. Applicant in the above-styled cause seeks an order (1) creating a non-standard, 200-acre, more or less, spacing and proration unit comprised of the S/2 N/2 of Section 9 and the SW/4 NW/4 (Unit E) of Section 10, Township 17 South, Range 32 East, NMPM, Lea County, New Mexico, and (2) pooling all mineral interests in the Yesso formation underlying this unit from a depth of 5000' to the base of the Blinberry. Said non-standard unit is to be dedicated to applicant's proposed Sneed 9 Federal Com No. 23H Well, which will be horizontally drilled from a surface location in the SW/4 NW/4 (Unit E) of Section 9 to a standard bottom hole location in the SW/4 NW/4 (Unit E) of Section 10. The completed interval for this well will remain within the 330-foot standard offset required by the rules. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of COG Operating LLC as operator of the well and a 200% charge for risk involved in drilling said well. Said area is located approximately .5 miles south of Majamar, NM.
