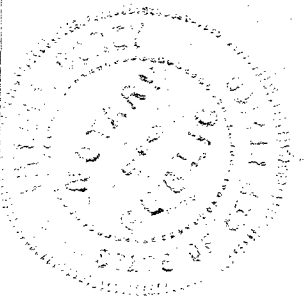

The one Fruitland Coal 320 acre unit and two Pictured Cliffs 160 acre units will be dedicated to the Dugan 29-12-22 Well No.109, to be located at an orthodox location in the SW/4 of Section 22, and the Dugan 29-12-22 Well No.109, to be located at an orthodox location in the NW/4 of Section 22. Also to be considered will be the cost of drilling and completing the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells. The application is scheduled to be heard at 8:15 a.m. on September 22nd 2005 at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505. As an interest owner in one or both wells unit you have the right to enter an appearance and participate in the case. Failure to appear will preclude you from contesting this matter at a later date. A portion of the unit is located within Farmington New Mexico city limits south of East Murry Drive, along the San Juan River.
