

Dear Scott:

This responds to your letter faxed at the close of business yesterday. Please specify the reasons Kaiser and Samson are requesting a four point test, including a description of each well in New Mexico where each operator has implemented such a test so Chesapeake can better evaluate your request.

The OCD's order concerning the drilling of the well did not contemplate the conducting of such a test and your threat to present this matter to the Division premised upon a contention that Chesapeake is somehow denying Kaiser and Samson access to information is baseless. In that regard, I have been told that there are no guards posted at the drill site, no one at Chesapeake has seen anyone from Samson or Kaiser at the site and no one been denied access.. If Kaiser or Samson legitimately desires to witness any operations on the well, please coordinate this with me in advance. Chesapeake is willing to accommodate such requests, consistent with its concerns for safety in conducting operations at the site.
