RE: Letter dated September 30, 2015 – AMENDMENT TO JOINT OPERATING AGREEMENT

Article XVI, Paragraph “E” of that certain Joint Operating Agreement dated January 20, 2012, between Burnett Oil Co., Inc. as Operator, and Burnett Oil Company, et al., as Non-operator covering the W/2 and W/2 E/2 of Section 12, W/2 of Section 13, and all of Section 24, Township 17 South, Range 31 East, NMPM, Eddy County, New Mexico, except for the wellbore for the Knockabout Fed #1 Well (the “JOA”).

Dear Rita,

Reference is made to our letter dated September 30, 2015, wherein Burnett requested that all parties to the JOA amend the same to delete Article XVI, Paragraph “E” thereof. A copy of the September 30, 2015, letter is included herewith.

All parties to the JOA have agreed to delete the provision with the exception of Ard Oil Ltd., Ard Energy Group, Ltd. (collectively “Ard”) and COG. Ard has suggested to us that the provision is not enforceable as to it and we would tend to agree. Pursuant to the provision, Burnett and the other parties to the JOA are contractually precluded from attempting to obtain an assignment of Ard’s working interest in the contract area in which such interest has lapsed. As you are aware, when the JOA was signed the Ard interest was subject to a term assignment in favor of COG. The term assignment has lapsed as to certain lands covered thereby; and Burnett has now proposed the drilling of two wells on the contract area.

In May of this year, Burnett was furnished a reassignment(s) dated effective October 13, 2013, from COG to Ard of the lapsed interest. Further, COG has elected to go non-consent in the drilling of the recently proposed Burnett Nosler 12 DB4H well (the only well of the two COG has an interest in). Insofar as this is evidence that COG does not desire the Ard interest, nor want to take a new assignment of the Ard interest in the lapsed acreage, we would ask that COG allow Burnett, or another party to the JOA, to try and negotiate with Ard for its interest. Burnett has proposed both the Nosler 12 DB4H and EG6H wells to Ard and proposed that it join the JOA. To date, Ard has declined to participate on these terms. We would like to negotiate with Ard on different terms, but are precluded from doing so by the referenced provision in the JOA.

If amending the JOA to delete Article XVI, Paragraph "E" in its entirety as we originally proposed is problematic for COG, Burnett would alternatively propose that COG waive the provision in writing as to the Ard interest only as to the Nosler 12 DB4H and EG6H wells, or even the first of the two wells drilled.

In a phone conversation with Mr. Joseph Scott of COG on October 16, COG suggested that it would consider agreeing to the amendment if Burnett would agree to move the surface location for the Nosler 12 DB4H well out of Section 11 (or perhaps both well locations out of Section 11). Please understand that Burnett has received approved APD's for the wells, the same filed with the BLM June 22, 2015, and at this point feels this request is unreasonably burdensome. Nonetheless, Burnett stands ready to provide any reasonable accommodation to COG with regard to surface locations. We have initiated multiple lines of communication with COG to see if we can come to a solution whereby both parties will have adequate surface locations to develop their respective leaseholds.

We greatly appreciate your prompt attention to this request. If you have questions or would like to discuss this matter further please do not hesitate to contact us.
