APPLICANT'S STATEMENT OF CASE

COG Operating LLC seeks an order (1) creating a 320-acre, more or less, spacing and proration unit comprised of the W/2 E/2 of Section 21 and the W/2 E/2 of Section 28, Township 25 South, Range 29 East, NMPM, Eddy County, New Mexico; and (2) pooling all mineral interests in the Wolfcamp formation. Said non-standard unit is to be dedicated to applicant's proposed **Admiral Federal Com No. 2H Well**, which will be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of Section 28 to a standard bottom hole location in the NW/4

NE/4 (Unit B) of Section 21. The completed interval for this well will comply with the Division's setback requirements.


