STATEMENT OF THE CASE

Applicant BTA Oil Producers, LLC seeks an order (1) directing Cimarex Energy Company of Colorado (“Cimarex”) to shut-in its over-produced oil wells completed in the Berry; Bone Spring, North Pool underlying the S/2 S/2 of Section 30, Township 20 South, Range 35 East, NMPM, Lea County, New Mexico; (2) assessing production penalties to curtail future over-production and to compensate for all past over-production from said wells; and (3) directing Cimarex to comply with the Division’s oil proration rules for the Berry; Bone Spring North Pool and NMRA 19.15.20.9-12. Said wells are located approximately 16 miles southwest of Monument, New Mexico.

Nearburg Producing Company operates Bone Spring formation wells offsetting the Cimarex wells to the west in Section 25, Township 20 South, Range 35 East, NMPM, and its correlative rights are adversely affected by Cimarex’s overproduction. Nearburg Producing Company supports the relief requested by BTA Oil Producers.


