Gentlemen:

The Northeast Square Lake Unit (NM71003X), Eddy County, New Mexico, is terminated effective January 31, 2011, pursuant to 43 CFR 3186.1.20.b and per Unit Agreement Article 21(c), which states the following: "The term of this agreement shall remain in effect for such term and so long as Unitized Substances can be produced in paying.." This termination is subject to like approval by the State Commissioner of Public Lands.

Our records indicate that Northeast Square Lake Unit last produce on January 2011 from Unit wells #13 and #7., Eddy County, New Mexico. It has been determined that the Northeast Square Lake Unit is not capable of production in paying quantities since January 2011.

Thus, it has been determined that no successor Unit Operator has been selected or qualified and approved by the Authorized Officer of the BLM and thus the Unit is terminated effective January 31, 2011. This termination is subject to like approval by the State Commissioner of Public Lands.


Pursuant to 43 CFR 3183.4(b), Public Interest requirement has been fulfilled, and the following leases NMNM04421, NMNM026332, NMNM026418 and NMNM081381A are entitled to a two year extension pursuant to 43 CFR 3107.3-2 and 3107.4. This two year extension will expire January 31, 2013.

Copies of this letter are being distributed to the appropriate Federal agencies. It is requested that you furnish notice of this termination to each working interest owner, lessee and lessor.

A person contesting a decision shall request a State Director review of the Written Order.
