**APPLICATION OF THE NEW MEXICO OIL CONSERVATION DIVISION
THROUGH THE SUPERVISOR OF DISTRICT II FOR AN EMERGENCY ORDER
SUSPENDING CERTAIN APPROVED APPLICATIONS FOR PERMITS TO DRILL,
AND FOR ADOPTION OF SPECIAL RULES FOR DRILLING IN CERTAIN AREAS
FOR THE PROTECTIONS OF FRESH WATER, CHAVES AND EDDY COUNTIES,
NEW MEXICO**

THIRD AMENDED APPLICATION

The acting Supervisor of Oil Conservation Division (OCD) District II ("Applicant") hereby applies to the Director for adoption, after notice and hearing, of such special orders as may be required in the DESIGNATED AREA hereafter described, for the protection of sources of fresh water designated by the State Engineer. In support of this Application, Applicant would show the following:

[1] The DESIGNATED AREA in which a restrictive order is urgently needed consists of the lands in Chaves and Eddy Counties, New Mexico described in Exhibit A, attached hereto. The Designated Area has been revised in this Third Amended Application to add additional lands overlying the aquifers in the Roswell Artesian Basin.

[2] The SUBJECT POOLS, identified in Exhibit B, attached hereto, are those pools all or parts of which are located in the DESIGNATED AREA.

[3] The State Engineer has designated the threatened aquifer(s) as a source of fresh water to be protected.


