COG Production LLC ("COG"), as Operator, proposes to drill the Copperhead 31 Federal Com #3H well as a horizontal well at the above-captioned location, or at a legal location as approved by the governing regulatory agency, to a TVD of approximately 10,635' and a MD of 17,400' to test the Wolfcamp Formation ("Operation"). The total cost of the Operation is estimated to be \$7,990,696 and a detailed description of the cost is set out in the enclosed Authority for Expenditure ("AFE").

COG is proposing to drill this well under the terms of that certain Exhibit "E" (JOA) of the Exploration and Development Agreement, Avalon Project Area, dated effective May 24, 2010, by and between OXY USA Inc. and OGX Resources LLC, et al.
