3 to go through the docket. The first case I will call  
4 will be Case Number 15557, application of COG Operating,  
5 LLC for a nonstandard oil spacing and proration unit and  
6 compulsory pooling, Eddy County, New Mexico.

7 Call for appearances.

8 MR. LARSON: Good morning, Mr. Examiner.  
9 Gary Larson of the Santa Fe office of Hinkle Shanor for  
10 the Applicant, COG Operating.

11 EXAMINER McMILLAN: Any other appearances?  
12 Please proceed.

13 MR. LARSON: I do not have any witnesses.

14 EXAMINER McMILLAN: Okay.

15 MR. LARSON: May I proceed, Mr. Examiner?

16 EXAMINER McMILLAN: Please do.

17 MR. LARSON: At the previous hearing in  
18 this case on October 27th, COG requested a continuance  
19 based on the timing of its notice to a group of recently  
20 identified offset interest owners, all of whom own  
21 interest in the northwest quarter-northwest quarter, in  
22 Lot 1 of Section 32, Township 26 South, Range 20 East.

23 As COG's landman, Patrick Godwin, testified  
24 at the previous hearing, COG had sent notice letters to  
25 the offset interest owners on October 21st and had

1 published notice on October 23rd.

2 I have two exhibits to add to the record  
3 regarding the certified mail and publication notice.  
4 Marked as COG Exhibit 11 is a list of the offset  
5 interest owners who were notified, an example of the  
6 hearing notice letter that was sent to each of them and  
7 accompanying U.S. mail receipts green cards.

8 And marked as COG Exhibit 12 is an  
9 affidavit affirming that the notice was published in the  
10 Carlsbad Current-Argus on October 23rd, which is 18  
11 business days prior to today's hearing.

12 And I move the admission of COG Exhibit  
13 Numbers 11 and 12.

14 EXAMINER McMILLAN: Exhibits 11 and 12 may  
15 now be accepted as part of the record.

16 (COG Operating, LLC Exhibit Numbers 11 and  
17 12 are offered and admitted into evidence.)

18 MR. LARSON: And with that, I request that  
19 this case be taken under advisement.

20 EXAMINER McMILLAN: All right. Case Number  
21 15557 shall be taken under advisement. Thank you.
