STATEMENT OF THE CASE

APPLICANT

Applicant seeks an order approving a non-standard oil spacing and proration unit (project area) in the Bone Spring formation comprised of the W/2W/2 of Section 27 and the W/2NW/4 and NW/4SW/4 of Section 34, Township 25 South, Range 33 East, NMPM (280 acres). Applicant further seeks the pooling of all mineral interests in the Bone Spring formation underlying the non-standard unit.

OPPONENT

RSC owns working interests in the SW/4SW/4 of Section 34 and in adjoining acreage, and wishes to protect its correlative rights in its acreage from being drained by applicant's proposed well.

In addition, the notices in this case describe the formation being tested as the Wolfcamp formation, rather than the Bone Spring formation.


