Our records reflect the following:


- The Talco Unit Agreement was approved effective April 29, 1980.
- The date of last production from this unit was April 2016.
- Article 23 Effective Date and Term states the following: "the term of this agreement shall be for and during the time that unitized substances are produced in paying quantities from the Unit Area and so long thereafter as drilling, reworking or other operations (including secondary recovery operations) are prosecuted thereon without cessation of more than ninety (90) consecutive days, unless sooner terminated by working interest owners in the manner hereinafter provided.

In view of the above, pursuant to Article 23 of the Talco Unit Agreement, please be advised that the Commissioner of Public Lands has this date terminated the Talco Unit agreement effective June 27, 2016.
