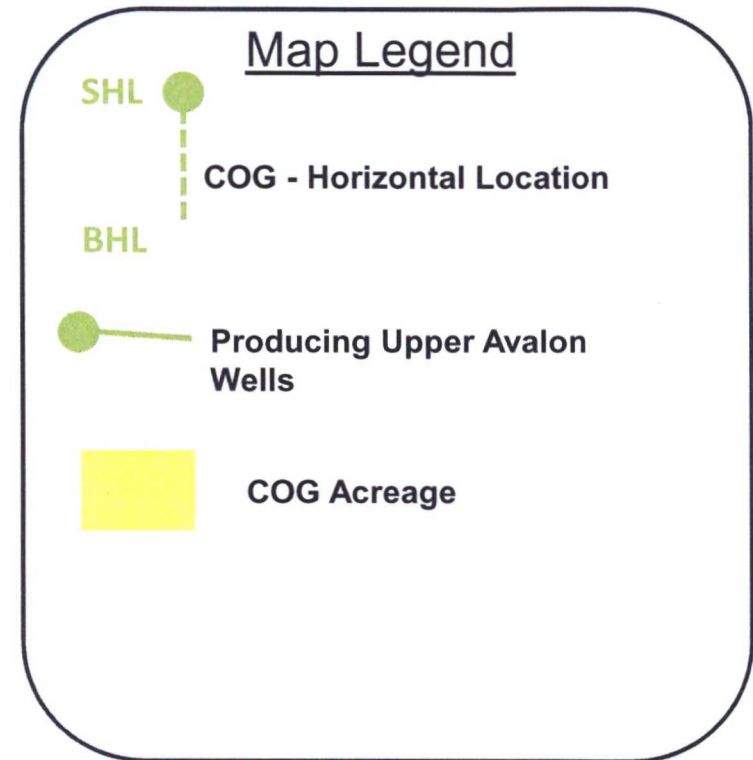

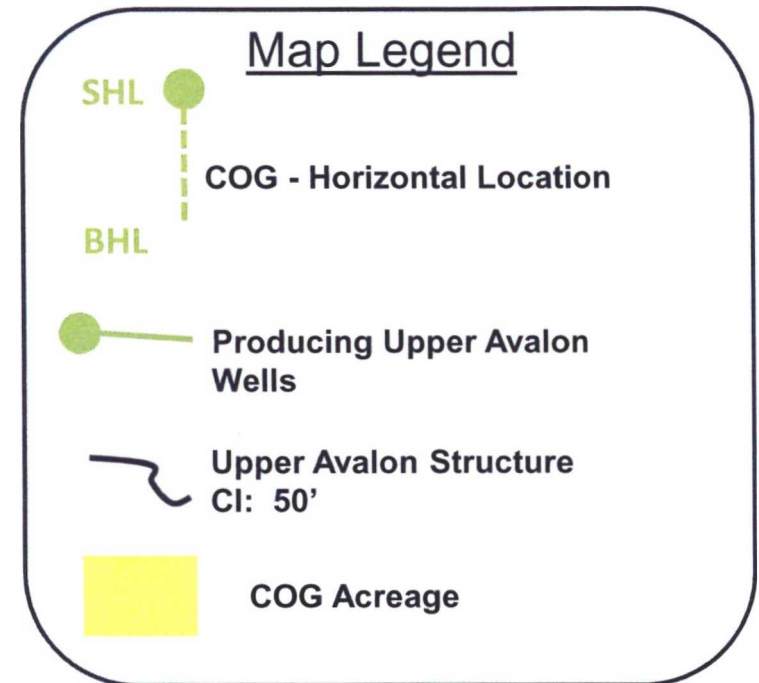
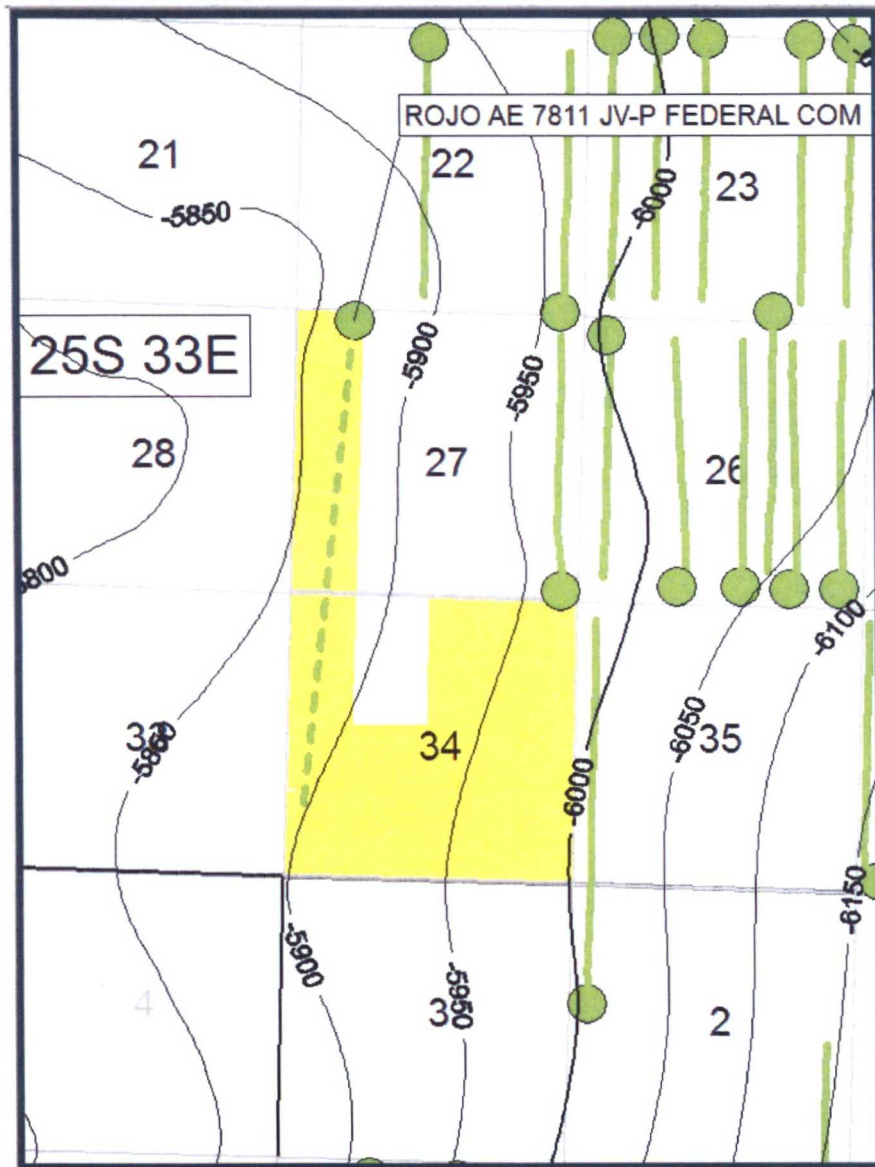

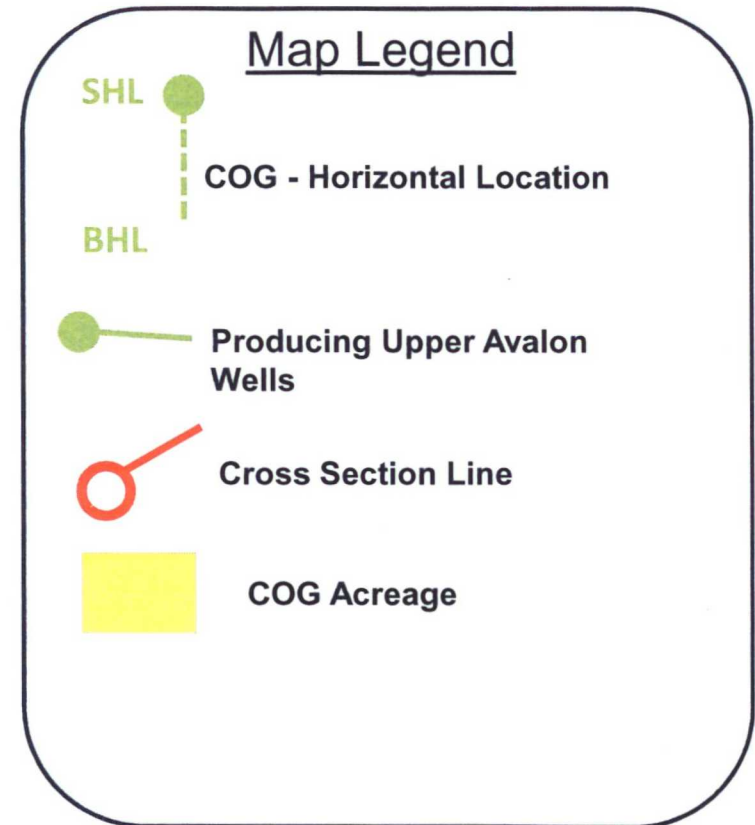
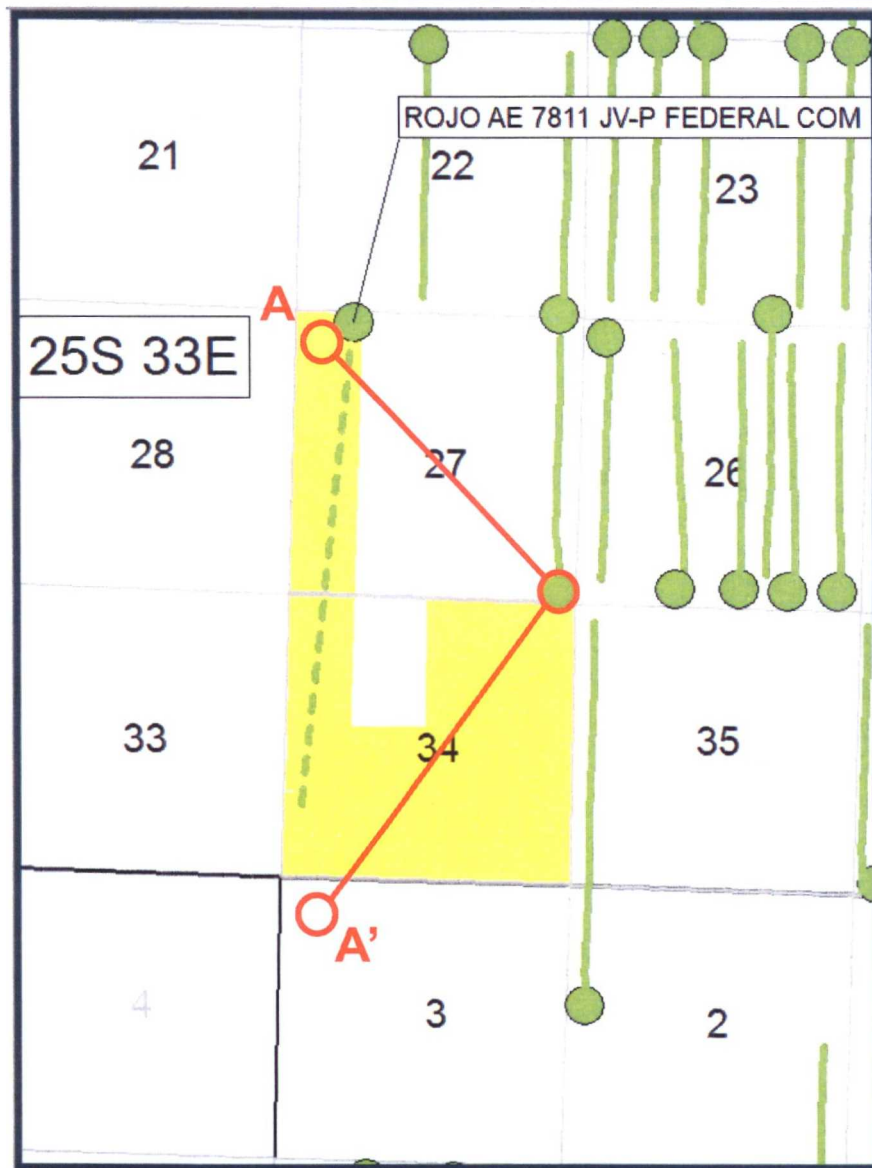
Bone Spring Pool Rojo AE 7811 JV-P Federal Com 1H Location
