MOTION TO CONTINUE

EOG Resources Inc (“EOG”) moves the Division to continue the above-referenced application currently scheduled for the April 13 2017 Examiner Hearing Docket to the May 11, 2017 Examiner Hearing Docket. In support of this motion, EOG states as follows

1 In Case No 15673, Mewbourne Oil Company (“Mewbourne”) seeks formation of a 480-acre non standard spacing unit comprised of the E/2 of Section 12 and the SE/4 of Section 1 Township 25 South, Range 27 East, NMPM, Eddy County New Mexico, and compulsory pooling of the Wolfcamp formation underlying said acreage

2 By mutual agreement, Mewbourne and EOG extended the deadline to file a motion to continue to 12 00 MST on April 11, 2017, rather than 5 00 MST on April 10, 2017. This motion is therefore timely

3 EOG entities own approximately 37 percent in Section 1 and an EOG entity is the operator of joint operating agreement covering all of Section 1 except the E/2 SE/4. An EOG entity is also the operator of a joint operating agreement covering the E/2 of Section 36. EOG is pursuing its own development plan for a two mile well to be drilled in the E/2 of Section 36 and the E/2 of Section 1

4 EOG has received a location for its two mile well and is in the process of proposing the well to interest owners and filing for compulsory pooling

5 Mewbourne and EOG's pooling applications will address the same acreage and should be consolidated for administrative efficiency


6 Counsel for Mewbourne has been contacted and opposes this motion


