2 EXAMINER JONES Okay Let's go on the  
3 record this morning

4 Good morning, everyone I'm William V  
5 Jones And the attorney for the Examiner this morning  
6 is David K Brooks, and assisting the Examiner this  
7 morning will be Leonard Lowe He'll be asking technical  
8 questions, hopefully one or two We'll ask him to ask  
9 some questions

10 And this is Docket Number 4-17 This is  
11 January the 19th, 2017, believe it or not It's a  
12 six-page docket Let's go through the continuances and  
13 the dismissals

14 On the first page, Case Number 15618 is  
15 continued to February the 2nd, 2017

16 And could I ask the attorney, Jordan  
17 Kessler for Holland & Hart, to talk about the  
18 continuance?

19 MS KESSLER Sure H1 My name is a  
20 Jordan Kessler I represent Holland & Hart in this case  
21 with WPX for the Rodeo Unit This case has actually  
22 been continued, refiled and continued to February 16th  
23 You'll be receiving another packet And the reason for  
24 the continuation is because the State Land Office  
25 acreage that was originally taken out of the unit will

1 be put back into the unit, so we had to send everybody  
2 notice again and re-advertise this and continue the  
3 case So I really apologize for the inconvenience

4 The landman for WPX is on his way, Brennan  
5 West He will be here shortly for questions If you  
6 have any questions, please feel free to come up and ask  
7 me Thank you

8 EXAMINER BROOKS You've got a hand back  
9 there

10 MR DANIEL TSO Daniel Tso And I got a  
11 letter from Holland & Hart basically saying that the  
12 hearing was for 1/17, but in the back of the packet, it  
13 was for 1/19, and that basically put a lot of questions  
14 And just the day before yesterday, my brother signed for  
15 a letter that said the case was postponed to February  
16 2nd Then on the NMOCD Web site, it said it was  
17 postponed to the 9th However, I talked directly with  
18 Ms Florene Davidson, and we clarified it's for February  
19 16th So if you could hurry up and get something in the  
20 mail to all the allotment heirs within the Rodeo Unit,  
21 so they won't be coming up on February 2nd or February  
22 6th I'd like that to be clarified for everybody

23 MS KESSLER Thank you I appreciate that  
24 clarification And you're correct There's been a lot  
25 of confusion with the hearing date We are trying our

1 best to notify everybody and send out the certified  
2 letters I appreciate you saying something And there  
3 is a letter going out this week with the February 16th  
4 hearing date

5 MR DANIEL TSO For me, you know what, I  
6 have a lot of suspicion of the way it's being operated,  
7 so that's how come I'm wanting that clarification

8 MS KESSLER Mr Examiners, the  
9 application was refiled on Tuesday with the amended  
10 acreage description, so Florene should have the  
11 corrected February 16th hearing date, and it's styled as  
12 an amended application

13 EXAMINER BROOKS Tuesday was February  
14 [sic] the 17th, so that gives you your 30 days

15 MS KESSLER January 17th, correct

16 EXAMINER JONES It was re-advertised, and  
17 what was changed?

18 MS KESSLER There was some amended  
19 acreage The State Land Office added some acreage, so  
20 it will have an expanded boundary

21 EXAMINER JONES Oh, okay Okay

22 So did everyone hear that? The notice that  
23 you got is going to be complete except for the State  
24 Land Office added some state land acreage to the  
25 proposed unit

1                   EXAMINER BROOKS     Since it was refiled, it  
2     will have a new case number

3                   EXAMINER JONES     It will say  
4     "re-advertised "

5                   EXAMINER BROOKS     Oh, okay,  
6     "re-advertised "   Okay

7                   EXAMINER JONES     It will have the same case  
8     number

9                   EXAMINER BROOKS     Same case number

10                  EXAMINER JONES     15618

11                  And Florene Davidson is the authority  
12     over -- she's our court clerk, so she keeps track of the  
13     continuances   And Jordan, with Holland & Hart, is in  
14     touch with her, in contact with her

15                  So we do appreciate you coming, and we hope  
16     you come to the case

17                  EXAMINER BROOKS     And we apologize for the  
18     confusion, not that that does any good

19                  MR DANIEL TSO     I guess the reason I'm  
20     saying it is because not every one of the allotment  
21     heirs have access to the Internet or even a cell phone  
22     Cell phone coverage is very limited out in that area

23                  EXAMINER JONES     Thank you, Daniel

24                  Okay   Let's continue on the docket on the  
25     continuances   And on page 2, Case 15621 is continued to

1 March the 2nd. Case 15604 is dismissed. Case 15613 is  
2 dismissed.

3 On page 3, Case 15614 is dismissed. Case  
4 15615 is dismissed, and Case 15616 is continued to  
5 February the 2nd.

6 And on page 4, Case 15586 is continued to  
7 February the 2nd. Case 15573 is dismissed. Case 15574  
8 is dismissed. Case 15575 is dismissed.

9 On page 5, all the cases are dismissed.  
10 Those are Cases 15576, 15577, 15578 and 15579. Those  
11 cases are all dismissed.

12 On page 5, those cases are dismissed.  
13 Those cases are 15580 and 15581.

14 That concludes the pre-hearing transcript  
15 of the docket -- for the docket.

16 Any changes or -- or --

17 MR. BRUCE: Mr. Examiner, on page 4, did  
18 you continue the first case, 15594?

19 EXAMINER JONES: No.

20 MR. BRUCE: I think Jordan and I had agreed  
21 to continue that for two weeks.

22 EXAMINER JONES: So that's continued to  
23 Ground Hog Day, February the 2nd. That is Case 15594.

24 Thank you, Mr. Bruce.

25 I didn't see it in the case file. Sorry

1 about that

2 Okay We've got a short docket, then  
3 (Pre-hearing proceedings conclude, 8 31
