Matador Production Company seeks an order (1) creating a 160-acre, more or less, spacing and proration unit comprised of the E/2 W/2 of Section 31 Township 18 South Range 35 East, NMPM Lea County, New Mexico and (2) pooling all uncommitted mineral interests in the Bone Spring formation The Unit will be the project area for the proposed **Airstrip 31-18S-35E RN State Com #132H Well**, which will be horizontally drilled from a surface location in the SE/4 SW/4 (Unit N) to a standard bottom hole location in the NE/4 NW/4 (Unit C) of Section 31 This project area is located within the




