COG Operating LLC seeks an order (1) creating a non-standard 320 02-acre, more or less spacing and proration unit in the Bone Spring formation comprised of the W/2 W/2 of Section 1 and the W/2 W/2 of Section 12, Township 22 South Range 33 East, NMPM Lea County, New Mexico, and (2) pooling all uncommitted interests in the Bone Spring formation underlying this acreage COG proposes to dedicate the above referenced spacing and proration unit as the project area for the proposed **Tenderloin Federal Com No 4H Well**, which will be drilled from a surface location in the SW/4 SW/4 (Unit M) of Section 12 to a standard bottom


