**STATEMENT OF THE CASE**

Marathon Oil Company ("Marathon") has acquired the interests of Black Mountain Operating LLC and is succeeding it as Operator. Marathon seeks an order (1) approving a non-standard oil spacing and proration unit in the Bone Spring formation comprised of the W/2SW/4

of Section 35, Township 21 South, Range 34 East, NMPM, Lea County, New Mexico, and the W/2W/2 of Section 2, Township 22 South, Range 34 East, NMPM, Lea County, New Mexico; and (2) pooling all mineral interests in the Bone Spring formation underlying the non-standard unit, and approving an unorthodox well location. The July 20, 2017 is being convened to follow-up on limited issues raised at the May 11, 2017 hearing. Marathon reserves the right to provide supplemental testimony and exhibits.


