OneEnergy Partners Operating, LLC ("OEP"), as Operator, hereby proposes drilling and completing the Parade BWY State Com 1H well (the "Well") to test the Wolfcamp formation ("Operation"). The estimated costs associated with the Operation are \$8,766,875.00, as outlined in the enclosed Authority For Expenditure dated April 11, 2017 ("AFE"). OEP's records indicate Western Commerce Bank, Agent for the Schenck Trust A-2 owns a 0.05891832 working interest in the Well, and Western Commerce Bank, Agent for the Schenck Trust A-2's estimated costs associated with the Operation is approximately \$516,529.50.

In addition, OEP hereby proposes the Operation under the terms of a modified 2015 Horizontal AAPL Form 610 Operating Agreement ("OA") with the following basic terms:

- Contract Area consisting of Township 25 South, Range 35 East, Section 2: W/2E/2 & Section 11: W/2NE/4, with OEP listed as the Operator ("Contract Area")
- 100%/300%/300% non-consent risk penalties
- \$7,000.00/\$700.00 drilling and producing overhead rates

A copy of the OA will be sent in the very near future. In the event Western Commerce Bank, Agent for the Schenck Trust A-2 chooses not to participate, OEP is willing to propose the following alternatives:

- Western Commerce Bank, Agent for the Schenck Trust A-2 farmout its leasehold interest in the Contract Area, delivering to OEP all of its working interest and leasehold interest, reserving an overriding royalty interest equal to the positive difference, if any, between twenty-five percent (25%) and existing leasehold burdens, subject to proportionate reduction, with the option to convert said overriding royalty interest into a proportionately reduced twenty-five percent (25%) working interest in the Well and associated project area upon payout of the Well.
- Western Commerce Bank, Agent for the Schenck Trust A-2 lease its entire working interest in the Contract Area to OEP for One Thousand Five Hundred dollars (\$1,500.00) per net mineral acre and Twenty-five percent (25%) royalty. 




