APPLICANT'S STATEMENT OF CASE

Applicant in the above-styled cause seeks an order (1) creating a 160-acre, more or less, spacing and proration unit comprised of the N/2 N/2 of Section 10, Township 24 South, Range 28 East NMPM, Eddy County, New Mexico; and (2) pooling all uncommitted mineral interests in the Bone Spring formation. Said non-standard unit is dedicated to applicants proposed **Guitar 10-24S-28E RB No. 121H Well**, which will be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 11 to a standard bottom hole location in the NW/4 NW/4 (Unit D) of Section 10. The completed interval for this well will remain within the 330-foot standard offset required by the Statewide Rules set forth in 19.15.15 NMAC.

COG objects to the application as an offset lessee because Matador's proposed surface location is on COG lease. COG was not provided notice or opportunity to discuss from Matador until receipt of this application.




