

CASE 8033: In the matter of the hearing called by the Oil Conservation Division on its own motion for an order creating, abolishing, reclassifying, and extending certain pools in Chaves, Eddy, Lea, and Roosevelt Counties, New Mexico:

- (a) CREATE a new pool in Eddy County, New Mexico, classified as an oil pool for Delaware production and designated as the East Avalon-Delaware Pool. The discovery well is the Exxon Corporation Burton Flat B Federal Well No. 1 located in Unit E of Section 1, Township 21 South, Range 27 East, NMPM. Said pool would comprise:

- (b) CREATE a new pool in Eddy County, New Mexico, classified as an oil pool for Delaware production and designated as the West Corral Canyon-Delaware Pool.
