APPLICANT'S STATEMENT OF CASE

Matador seeks to amend Division Order R-14432 to change the initial well. Order R-14432 created a 155.29-acre spacing and proration unit consisting of the N/2 S/2 of Section 19, Township 20 South, Range 29 East, NMPM, in Eddy County, New Mexico and pooled uncommitted interests in the Bone Spring Formation (Russell; Bone Spring Pool (52805)). The spacing unit was dedicated to the **Stebbins 19 Federal Com No. 133H** (API No. 30-015-44174), a horizontal well to be drilled from a surface location 2347 feet from the South line and 520 feet from the East line (Unit I) to a bottom hole location 1870 feet from the South line and 240 feet from the West line (Lot 3) of Section 19. Since the entry of Order R-14432, Matador has changed the initial well

within the Bone Spring formation. The spacing unit will be dedicated to the **Stebbins 19 Federal Com No. 123H** (API No. 30-015-44170), a horizontal well to be drilled 2317 feet from the South line, 520 feet from the East line (Unit I) to a standard bottom hole location 1870 feet from the South line, 240 feet from the West line of Section 19. All other aspects of Order R-14432 remain unchanged.


