APPLICATION OF MEWBOURNE OIL COMPANY FOR A NON-STANDARD GAS SPACING AND PRORATION UNIT AND COMPULSORY POOLING, EDDY COUNTY, NEW MEXICO.

#### **ORDER OF THE DIVISION**

#### **BY THE DIVISION:**

This case came on for hearing at 8:15 a.m. on October 26, 2017 at Santa Fe, New Mexico, before Examiner Scott A. Dawson.

NOW, on this 30th day of November, 2017, the Division Director, having considered the testimony, the record and the recommendations of the Examiner,

## **FINDS THAT:**

- (1) Due public notice has been given, and the Division has jurisdiction of this case and of the subject matter.
- (2) Mewbourne Oil Company ("Applicant or Mewbourne"), seeks approval of a 479.88-acre non-standard gas spacing and proration unit and project area ("the Unit") for oil and gas production from the Wolfcamp formation, Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) comprising Lot 1, Lot 2, S/2 NE/4 and SE/4 (E/2 equivalent) of Section 6, and the NE/4 of Section 7, all in Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico. Applicant further seeks an order pooling all uncommitted interests in the Unit for the Wolfcamp formation.
  - (3) The Unit will be dedicated to the following "Proposed Wells":
    - a. Motley 6 7 WOAH Fee Com Well No. 1H (the "proposed well"; API No. 30-015-44466), a horizontal well to be drilled from a surface location 335 feet from the North line and 970 feet from the East line (Lot 1/Unit A) of Section 6, to a bottom-hole location 2310 feet from the North line and 330

- feet from the East line (Unit H) of Section 7, both in Township 24 South, Range 28 East, NMPM.
- b. Motley 6 7 W2AH Fee Com Well No. 2H API No. (30-015-43802), a horizontal well to be drilled from a surface location 305 feet from the North line and 920 feet from the East line (Lot 1/Unit A) of Section 6, to a bottom-hole location 2310 feet from the North line and 330 feet from the East line (Unit H) of Section 7, both in Township 24 South, Range 28 East, NMPM.
- c. The location of the completed interval for both proposed wells will be standard for horizontal gas wells within the Unit.
- (4) The proposed wells are within the Purple Sage; Wolfcamp (Gas) Pool (Pool code 98220), which is governed by special pool rules as established by Division Order No. R-14262 which provide for 330-foot setbacks from a standard 320-acre gas spacing unit. The proposed Unit and project area consists of three adjacent quarter sections oriented north to south.
- (5) Applicant appeared through counsel and presented the following land and geologic evidence:
  - (a) the Wolfcamp formation in this area is suitable for development by horizontal drilling;
  - (b) the proposed orientation of the horizontal wells from north to south is appropriate for the Unit;
  - (c) all quarter sections to be included in the Unit are expected to be productive in the Wolfcamp formation, so that the Unit as requested will not impair correlative rights;
  - (d) all parties were located and all pooled parties are either working interests or unmarketable interests;
  - (e) notice by certified mail was provided to all uncommitted interest owners in the proposed Unit whose interests were evidenced by a conveyance instrument, either of record or known to Applicant when the Application was filed, and to heirs known to Applicant of deceased persons who appear as owners in such instruments, and whose whereabouts could be ascertained by exercise of reasonable diligence; and
  - (f) those potentially affected parties whose whereabouts could not be ascertained were noticed by publication as provided in Rule 19.15.4.12.B NMAC.

(6) No other party appeared or otherwise opposed this application.

The Division concludes as follows:

- (7) The proposed non-standard unit should be approved to enable Applicant to drill horizontal wells that will efficiently produce the reserves underlying the Unit, thereby preventing waste and protecting correlative rights.
- (8) Two or more separately owned tracts are embraced within the Unit, and/or there are royalty interests and/or undivided interests in oil and gas minerals in one or more tracts included in the Unit that are separately owned.
- (9) Applicant is owner of an oil and gas working interest within the Unit. Applicant has the right to drill and proposes to drill the proposed wells to a common source of supply within the Unit at the proposed location.
- (10) There are interest owners in the Unit that have not agreed to pool their interests.
- (11) To avoid the drilling of unnecessary wells, protect correlative rights, prevent waste and afford to the owner of each interest in the Unit the opportunity to recover or receive without unnecessary expense a just and fair share of hydrocarbons, this application should be approved by pooling all uncommitted interests, whatever they may be, in the oil and gas within the Unit.
- (12) Mewbourne Oil Company (OGRID 14744) should be designated the operator of the proposed wells and the Unit.
- (13) Any pooled working interest owner who does not pay its share of estimated well costs of either well should have withheld from its share of production from such well, its share of reasonable well costs of such well plus an additional 200% thereof as a reasonable charge for the risk involved in drilling the subject well.
- (14) Reasonable charges for supervision (combined fixed rates) are hereby fixed at \$8000 per month, per well, while drilling and \$800 per month, per well, while producing, provided that these rates may be adjusted annually pursuant to the Overhead section of the COPAS form titled "Accounting Procedure-Joint Operations." The operator is authorized to withhold from each pooled working interest owner's share of production from each well the proportionate share of both the supervision charges and the actual expenditures required for operating such well, not more than what are reasonable.

### **IT IS THEREFORE ORDERED THAT:**

(1) Pursuant to the application of Mewbourne Oil Company, a 479.88-acre non-standard gas spacing and proration unit and project area (the "Unit") is hereby established for oil

and gas production from the Wolfcamp formation, Purple Sage; Wolfcamp (Gas) Pool (Pool code 98220), comprising Lot 1, Lot 2, S/2 NE/4 and SE/4 (E/2 equivalent) of Section 6, and the NE/4 of Section 7, all in Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico.

- (2) All uncommitted interests, whatever they may be, in the oil and gas in the Wolfcamp formation underlying the Unit, are hereby pooled.
  - (3) The Unit shall be dedicated to the following "Proposed Wells":
    - a. Motley 6 7 WOAH Fee Com Well No. 1H (the "proposed well"; API No. 30-015-44466), a horizontal well to be drilled from a surface location, 335 feet from the North line and 970 feet from the East line (Lot 1/Unit A) of Section 6, to a bottom-hole location 2310 feet from the North line and 330 feet from the East line (Unit H) of Section 7, both in Township 24 South, Range 28 East, NMPM.
    - b. Motley 6 7 W2AH Fee Com Well No. 2H API No. (30-015-43802), a horizontal well to be drilled from a surface location 335 feet from the North line and 920 feet from the East line (Lot 1/Unit A) of Section 6, to a bottom-hole location 2310 feet from the North line and 330 feet from the East line (Unit H) of Section 7, both in Township 24 South, Range 28 East, NMPM.
    - c. The locations of the completed intervals for both proposed wells will be standard for horizontal gas wells within the Unit.
- (4) The operator of the Unit shall commence drilling the first proposed well on or before November 30, 2018, and shall thereafter continue drilling the proposed well with due diligence to test the Wolfcamp formation.
- (5) In the event the operator does not commence drilling at least one of the proposed wells on or before November 30, 2018, Ordering Paragraphs (1) and (2) shall be of no effect, unless the operator obtains a time extension from the Division Director for good cause demonstrated by satisfactory evidence.
- (6) Unless at least one of the proposed wells is drilled and completed within 120 days after commencement of the first proposed well, then Ordering Paragraphs (1) and (2) shall be of no further effect, and the Unit and project area created by this order shall terminate, unless operator appears before the Division Director and obtains an extension of the time for completion of one of the proposed wells for good cause shown by satisfactory evidence. If neither of the proposed wells is completed in all of the standard spacing units included in the proposed project area (or Unit) then the operator shall apply to the Division for an amendment to this order to contract the Unit so that it includes only those standard spacing units in which at least one well is completed.

- (7) Upon final plugging and abandonment of the proposed wells and any other well drilled on the Unit pursuant to Division Rule 19.15.13.9 NMAC, the pooled Unit shall terminate, unless this Order has been amended to authorize further operations.
- (8) Mewbourne Oil Company (OGRID 14744) is hereby designated the operator of the wells and the Unit.
- (9) After pooling, uncommitted working interest owners are referred to as pooled working interest owners. ("Pooled working interest owners" are owners of working interests in the Unit, including unleased mineral interests, who are not parties to an operating agreement governing the Unit.) After the effective date of this order, the operator shall furnish the Division and each known pooled working interest owner in the Unit an itemized schedule of estimated costs of drilling, completing and equipping each of the proposed wells ("well costs").
- (10) Within 30 days from the date the schedule of estimated well costs for any well is furnished, any pooled working interest owner shall have the right to pay its share of estimated well costs of such well to the operator in lieu of paying its share of reasonable well costs out of production as hereinafter provided, and any such owner who pays its share of estimated well costs as provided above for any well shall remain liable for operating costs but shall not be liable for risk charges for such well. Pooled working interest owners who elect not to pay their share of estimated well costs as provided in this paragraph shall thereafter be referred to as "non-consenting working interest owners."
- (11) The operator shall furnish the Division and each known pooled working interest owner (including non-consenting working interest owners) an itemized schedule of actual well costs within 90 days following completion of each of the proposed wells. If no objection to the actual well costs is received by the Division, and the Division has not objected, within 45 days following receipt of the schedule, the actual well costs shall be deemed to be the reasonable well costs. If there is an objection to actual well costs within the 45-day period, the Division will determine reasonable well costs after public notice and hearing.
- (12) Within 60 days following determination of reasonable well costs for any well, any pooled working interest owner who has paid its share of estimated costs in advance as provided above shall pay to the operator its share of the amount that reasonable well costs exceed estimated well costs and shall receive from the operator the amount, if any, that the estimated well costs it has paid exceed its share of reasonable well costs.
- (13) The operator is hereby authorized to withhold the following costs and charges from each non-consenting owner's share of production from each well:
  - (a) The proportionate share of reasonable well costs attributable to such interest; and

- (b) As a charge for the risk involved in drilling the well, 200% of the above costs.
- The operator shall distribute the costs and charges withheld from production, proportionately, to the parties who advanced the well costs.
- Reasonable charges for supervision (combined fixed rates) are hereby fixed at \$8000 per month per well while drilling and \$800 per month per well while producing, provided that these rates may, at the election of the operator, be adjusted annually pursuant to the overhead adjustment provisions of the COPAS form titled "Accounting Procedure-Joint Operations." The operator is authorized to withhold from each pooled working interest owner's share of production from each well the proportionate share of both the supervision charges and the actual expenditures required for operating the well(s), not more than what are reasonable.
- Except as provided above, all proceeds from production from the proposed wells that are not disbursed for any reason shall be held for the account of the person or persons entitled thereto pursuant to the Oil and Gas Proceeds Payment Act (NMSA 1978 Sections 70-10-1 through 70-10-6, as amended). If not disbursed, such proceeds shall be turned over to the appropriate authority as and when required by the Uniform Unclaimed Property Act (NMSA 1978 Sections 7-8A-1 through 7-8A-31, as amended).
- Any unleased mineral interest shall be considered a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest for allocating costs and charges under this Order. Any well costs or charges that are to be paid out of production shall be withheld only from the working interests' share of production, and no costs or charges shall be withheld from production attributable to royalty interests.
- Should all the parties to this compulsory pooling order reach voluntary agreement after entry of this order, this order shall thereafter be of no further effect.
- The operator of the wells and the Unit shall notify the Division in writing of the subsequent voluntary agreement of parties subject to the compulsory pooling provisions of this order.
- Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
