

STATEMENT OF CASE

APPLICANT:

Applicant seeks an order pooling all mineral interests in the Canyon formation underlying the NE/4 of Section 34, Township 6 North, Range 34 East, NMPM, for all pools or formations developed on 160 acre spacing within the vertical extent, including the WC0009 No. 63434G, Canyon Gas Pool. The unit will be dedicated to the Frio Lands #1 Well, a vertical well with a surface location 1929 FNL and 1962 FEL of Section 34. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well and a 200% charge for the risk involved in drilling and completing the well. The spacing unit is located approximately 20 miles north of Clovis, New Mexico.
