**APPLICANT'S STATEMENT OF CASE**

Ameredev seeks an order (1) creating a 233.69-acre, more or less, spacing and proration unit comprised of the W/2 W/2 of Section 27 and the W/2 NW/4 (W/2 W/2 equivalent) of irregular Section 34, Township 26 South, Range 36 East, NMPM, Lea County, New Mexico; and (2) pooling all uncommitted mineral interests in the Wolfcamp formation. Ameredev proposes to dedicate the above-referenced spacing and proration unit as the project area for its proposed **Amen Corner State Com 26-36-27 No. 111H Well**, which will be horizontally drilled from a

surface location in the SW/4 SW/4 (Unit M) of Section 22, Township 26 South, Range 36 East to a standard bottom hole location in the SW/4 NW/4 (Lot 4) of irregular Section 34, Township 26 South, Range 36 East. The completed interval for this well will remain within the 330-foot standard offset required by the Statewide Rules set forth in 19.15.15 NMAC.
