COBALT'S STATEMENT OF CASE

Cobalt Operating, LLC ("Cobalt") (OGRID No. 286255) has three wells out of a total of 11 wells out of compliance. *See* Bureau Application at ¶ 14. One of the three non-compliant wells on the in-active well list is the Angel No. 2 well (API No. 30-025-07136). *See* Ex. 2 to Bureau Application. Cobalt has successfully returned that well to production, reducing the number of wells on the inactive well list to two wells. Cobalt, therefore, is no longer out of compliance with 19.15.5.9(A)(4) NMAC. Cobalt will supplement the record and the Division's files to confirm that the Angel No. 2 well has been returned to production. Cobalt therefore requests a continuance of two weeks.


