You have requested to drill this horizontal well at an unorthodox oil well location described above in the referenced pool or formation. Subsection B of 19.15.15.9 NMAC governs this pool and provides for 40-acre units, with wells located at least 330 feet from a unit outer boundary.

This well's completed interval is as close as 100 feet to the southern edge, 345 feet to the southwestern and northwestern edges, and 100 feet to the northern edge of the project area. Encroachments will impact the following tracts.

Section 19, T21S R33E encroachment to the N2 NE4 Section 7, T21S R33E encroachment to the S2 SE4
