**APPLICATION OF BTA OIL PRODUCERS, LLC

APPLICATION

BTA Oil Producers, LLC ("BTA") by and through its undersigned attorneys, applies for an order approving a salt water disposal well. In support of this application, BTA states:

1. In March of 2018, BTA (OGRID 260297) filed an administrative application for authorization to inject produced water into the Devonian formation through its proposed White River SWD Well No. 1 well (API No. 30-015-44813) to be located 940 feet from the North line and 340 feet from the West line (Unit D) in Section 29, Township 23 South, Range 28 East, NMPM, Eddy County, New Mexico.

2. BTA seeks authority to inject produced water into the Devonian formation at a depth of 13,729-15,000 feet by an open hole system.

3. Notice of BTA's administrative application was provided by certified mail to the surface owner and all affected operators. Public notice was also provided in a local newspaper.

4. In April BTA was notified by the Division that Marathon Oil Permian LLC Oil Company filed a protest of BTA's application. *See* Email attached hereto. BTA's efforts to discuss this protest with Marathon have not been successful.


5. BTA requests that this matter be set for hearing before a Division Examiner. Notice of the filing of this application has been provided to Marathon by certified mail through its counsel of record.
