

**APPLICATION OF ASCENT ENERGY, LLC
FOR COMPULSORY POOLING, LEA COUNTY,
NEW MEXICO.**Case No. 16484**APPLICATION**

Ascent Energy, LLC applies for an order pooling all mineral interests in the Bone Spring formation underlying a horizontal spacing unit comprised of the W $\frac{1}{2}$ E $\frac{1}{2}$ of Section 28 and the W $\frac{1}{2}$ E $\frac{1}{2}$ of Section 33, Township 20 South, Range 33 East, N.M.P.M., Lea County, New Mexico, and in support thereof, states:

1. Applicant is an interest owner in the W $\frac{1}{2}$ E $\frac{1}{2}$ of Section 28 and the W $\frac{1}{2}$ E $\frac{1}{2}$ of Section 33, and has the right to drill a well or wells thereon.
2. Applicant proposes to drill the following wells to test the Bone Spring formation:
 - (a) the Gavilon Fed. Com. Well No. 506H; and
 - (b) the Gavilon Fed. Com. Well No. 604H.

Applicant will dedicate the W $\frac{1}{2}$ E $\frac{1}{2}$ of Section 28 and the E $\frac{1}{2}$ W $\frac{1}{2}$ of Section 33 to the wells to form a 320-acre horizontal spacing unit in the Bone Spring formation. The wells are horizontal wells, with first take points in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 33, and final take points in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 28.

3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the Bone Spring formation in the W $\frac{1}{2}$ E $\frac{1}{2}$ of Section 28 and the W $\frac{1}{2}$ E $\frac{1}{2}$ of Section 33 for the purposes set forth herein.

4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the wells or to otherwise commit their interests to the wells, certain interest owners have failed or refused to join in dedicating their interests.

Therefore, applicant seeks an order pooling all mineral interest owners in the Bone Spring formation in the W½E½ of Section 28 and the W½E½ of Section 33, pursuant to NMSA 1978 §70-2-17.

5. The pooling of all mineral interests in the Bone Spring formation underlying the W½E½ of Section 28 and the W½E½ of Section 33 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

- A. Pooling all mineral interests in the Bone Spring formation underlying the W½E½ of Section 28 and the W½E½ of Section 33;
- B. Designating applicant as operator of the wells;
- C. Considering the cost of drilling and completing the wells, and allocating the cost among the wells' working interest owners;
- D. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and
- E. Setting a 200% charge for the risk involved in drilling and completing the wells in the event a working interest owner elects not to participate in the wells.

PROPOSED ADVERTISEMENT

Case No. 16484 :

Application of Ascent Energy, LLC for compulsory pooling, Lea County, New Mexico.
Applicant seeks an order pooling all mineral interests in the Bone Spring formation underlying a 320-acre horizontal spacing unit in the Bone Spring formation comprised of the W/2E/2 of Section 28 and the W/2E/2 of Section 33, Township 20 South, Range 33 East, NMPM. The unit will be dedicated to the Gavilon Fed. Com. Well No. 506H and the Gavilon Fed. Com. Well No. 604H, horizontal Bone Spring wells with first take points in the SW/4SE/4 of Section 33 and last take points in the NW/4NE/4 of Section 28. Also to be considered will be the cost of drilling and completing the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells. The unit is located approximately 3-1/2 miles east-southeast of Halfway, New Mexico.
