APPLICANT'S STATEMENT OF THE CASE

In Case No. 20141, NGL seeks an order approving disposal into the Silurian-Devonian formation through the Sparrow SWD #1 well. NGL proposes to drill this well at a surface location 405 feet from the North line and 297 feet from the West line of Section 11, Township 24 South, Range 33 East, NMPM, Lea County, New Mexico. The target injection interval is the Silurian-Devonian formation at a depth of 16,940' - 18,658'. NGL further seeks approval of the use of 7 inch tubing inside the surface and immediate casings, and 5½ inch tubing inside the liner and requests that the Division approve a maximum daily injection rate for the well of 50,000 bbls per day.


