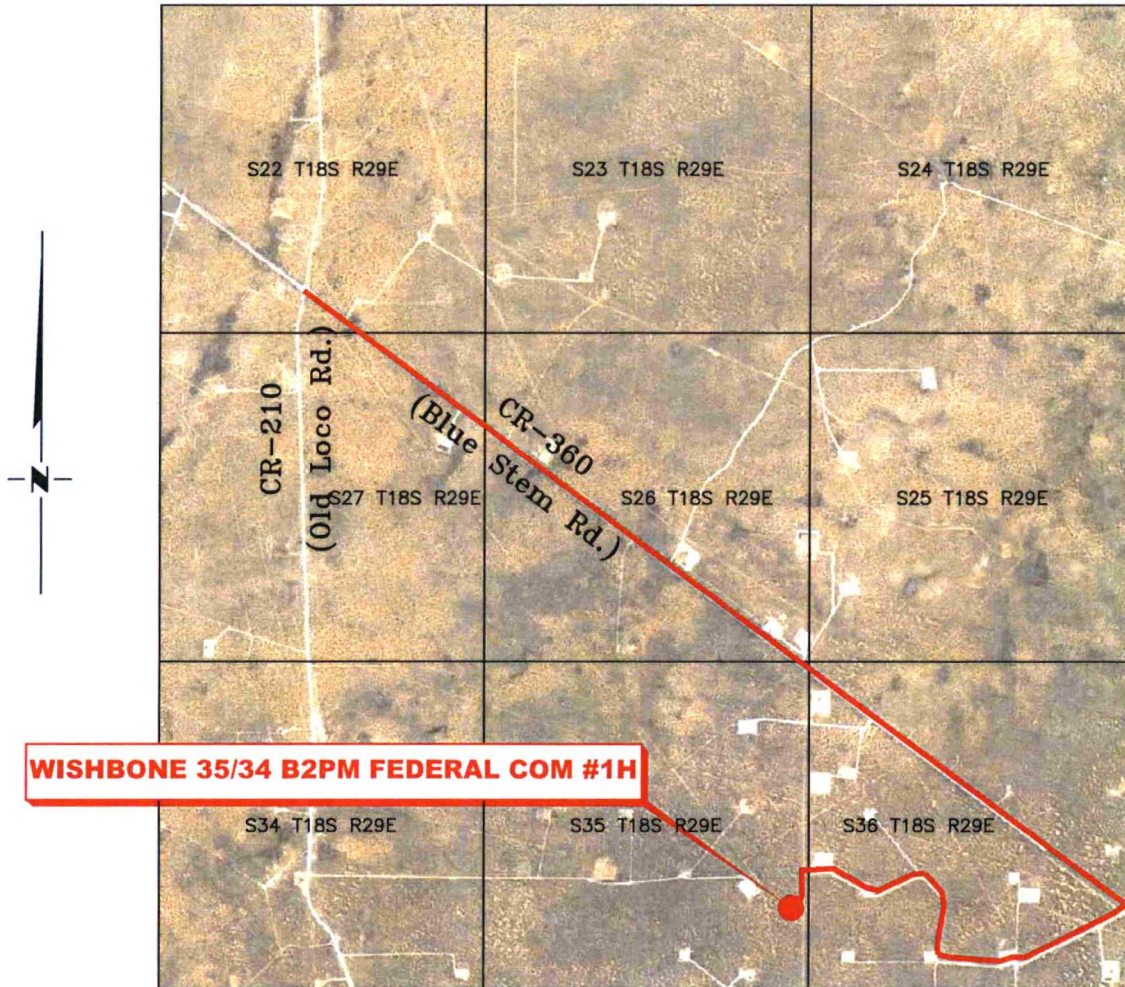

Mewbourne Oil Company ("Mewbourne") as Operator hereby proposes to form a 1,258.97 acre Working Interest Unit ("WIU") covering the referenced Sections 34 & 35, T25S, R28E for oil and gas production. The targeted interval for the proposed unit is the Wolfcamp formation. According to our records, OXY USA Inc. ("OXY") owns an interest in the proposed WIU.

Mewbourne Oil Company ("Mewbourne") as Operator hereby proposes to drill the referenced well at the above referenced surface location (SL) to the referenced bottom hole location (BHL). The proposed well will be drilled to an approximate true vertical depth (TVD) of 8,079 feet subsurface to evaluate the Wolfcamp Formation. 



Lauren,

Sorry it has taken us so long to get back to you on this, but in response to OXY's suggested changes for the captioned prospect above, please refer to our responses in red below:

- Page 2- strike lines 48-50

Ok, but this doesn't really come into play, since it is a 1,280 acre unit.

- Page 10- Make SEL \$50,000

We would like to keep this as \$75,000. \$75,000 is still minimal in the grand scheme of things, and other operators, such as Concho, have switched to this, as it is the going rate in the area.

- Page 11- paragraph G- change 10 days to 30

We need to keep this as 10 days. If need be, I can connect you with our Gas Balancing Department and someone can give you more explanation.

- Page 15- Strike lines 7-13
- Page 15-Strike the pref right

We would prefer to keep the two articles above the same, just mainly due to all the Private Equities that are currently around, and how fast title is switching hands. It helps us keep all the interests straight and keeps title more clear.

- Page 17- Article XV- paragraph A- select option 2

We would also prefer to keep this as Option No. 1, just mainly because we are doing much of the leg work to pool any non-participating parties.

- Page 18- Article XVI-paragraph D- change to 60 days

We would like to keep this as 30 days, because we need to know corrections ASAP for multiple purposes. Changing it to 60 would simply take too long to get replies.

- Add Oxy's self-insurance language to Ex. D. "Notwithstanding the foregoing, OXY USA INC shall have the right to self insure any of the foregoing insurance requirements and Operator shall not bill any portion of the premiums attributable to such policies against OXY USA INC, except with respect to workers' compensation as provided in Article V.D.9 of this Agreement. The foregoing is personal in nature to OXY USA INC and in the event OXY USA INC assigns its interest in this Agreement, the assignee pursuant to such assignment shall be responsible for its proportionate share of the premiums attributable to such policies."

In the past we usually just do a side Letter Agreement for this with OXY.

GBA:

- Page 6. In lines 1-3 strike " party taking Gas in kind is prohibited from taking Gas in kind through Operator's meter facilities with a pipeline company and Operator will not be obligated to construct or incur any cost other than a simple tap and value at Operator's gas sales meter site to deliver Gas to the Party taking Gas in kind."

This too is an area that our Gas Balancing Department says we simply can't change because that it is impossible due to the number of CDPs (Common Delivery Points) in the area. If a WI party decides they want to take-in-kind, we need to keep everything as separate as we possibly can. Once again, I can refer you to our Gas Balancing Department, and they can explain things more in depth if need be.
