STATEMENT OF THE CASE

Hilcorp seeks an order pooling all uncommitted interests in the Mesaverde formation underlying the S/2 of Section 30, Township 29 North, Range 10 West, NMPM, San Juan County, New Mexico, to form a standard 320-acre gas spacing unit within the Mesaverde formation. Hilcorp proposes to dedicate the above-reference spacing unit to its **Abrams Gas Com E 1 Well** (API No. 30-045-07815), to be recompleted at a standard gas well location in NE/4 SE/4 (Unit I)

of Section 30 to a depth sufficient to test the Mesaverde formation. The well was previously drilled and completed within the Dakota formation at a surface location 1,790 feet from the south line and 890 feet from the east line of Section 30, and a bottom-hole location approximately 1,790 feet from the south line and 890 feet from the east line of Section 30, and dedicated to a standard 320-acre gas spacing unit in the Basin-Dakota Pool (Pool Code 71599), comprised of the S/2 of Section 30.
