Enclosed is an approved copy of the Unit Agreement for the Blanco Wash Unit. This Unit has been assigned Agreement No. NMNM137065X. The lands committed to this agreement are identified in Exhibits A and B of the subject Unit. The Blanco Wash Unit Agreement unitizes rights as to oil and gas, producible from only the Mancos Formation. This Unit is hereby approved May 30, 2017, and made effective August 20, 2012...

All wells and facilities under the Blanco Wash Unit must display appropriate signage in accordance with Title 43 of the Code of Federal Regulations, Section 3162.6 (Section 43 CFR 3162.6). Signs shall include the well name and number, Operator name, lease number, <u>Unit Agreement number</u>, the quarter-quarter section, section, township and range, county, and state.

Upon approval of the Blanco Wash Unit Agreement, production and royalty reports are due to the Office of Natural Resources Revenue (ONRR). The submission of form **MMS-4054**, **Oil and Gas Operations Report (OGOR)**, must begin once drilling is completed. OGORs must be submitted to ONRR by the 15th day of the second month following the production month. Royalty payments, along with the form **MMS-2014**, **Report of Sales and Royalty Remittance**, are due on or before the last day of the month following the month during which oil or gas was produced and sold.

If the unitized well(s) are producing, any production royalties that are due must be reported and paid within 90 days of the Bureau of Land Management's approval date or the payors will be assessed interest for late payment under the Federal Oil and Gas Royalty Management Act of 1982 (Section 30 CFR 218.54). APPROVAL-CERTIFICATION-DETERMINATION

- A. Approve the attached Blanco Wash Unit Agreement covering the lands identified in Exhibits A and B of the subject Unit Agreement.

The Blanco Wash Unit Agreement, San Juan County, New Mexico is approved May 31, 2017 and is effective August 20, 2012. This agreement has been assigned case recordation number NMNM137065X. The basic information associated with this unit is as follows:

- 1. This is an Undivided Unit and only the Mancos Formation is unitized.
- 2. This unit includes Federal, Indian allotted, Fee, and State minerals.
- 3. The leases committed to the Blanco Wash Unit will not be horizontally segregated.
- 4. The Escrito I24-2409 #01H well, API # 30-045-35322 is the initial obligation well. The surface hole location is located in the NE/4SE/4, Section 24, T.24 N., R.9 W., San Juan County, New Mexico.
- 5. The following Federal leases contain lands both inside and outside the Blanco Wash Unit and are subject to segregation provisions pursuant to 43 CFR 3107.3-2, Segregation of leases committed in part:

a. NMNM 10755

Held By Actual Production

b. NMNM 97108

Held By Actual Production

c. NMNM 118136

Expires 05/31/2017

The Blanco Wash Unit embraces 13,128.47 acres more or less. All lands embraced within the Blanco Wash Unit are fully committed with the exception of two (2) tracts. The following two (2) tracts are non-committed:

- a. Tract 7, lease NMNM 23742 with 80.00 acres, located in the S/2SW/4, Section 5, T.24 N., R.9 W.,
- b. Tract 23, State lands with 320.00 acres, located in N/2, Sec. 16, T.24 N., R.9 W.,
- Tract 26, Fee land with 240.08 acres, located in Lot 7, SE/4SW/4, Sec. 6, T.24 N., R.8 W., and SE/4, Sec. 1, T.24 N., R.9 W.

In view of the foregoing commitment status, effective control of the unit area has been established. We are of the opinion that this agreement is in the public interest and for the purpose of more properly conserving natural resources.

Please continue your efforts to obtain joinder signatures and provide to us.

In accordance with Article 9 of the Blanco Wash Unit Agreement, the Escrito I24 2409 #01H well, API # 30-045-35322 has been drilled and was completed on October 12, 2012. The public interest requirement for the Blanco Wash Unit agreement has been satisfied. Pursuant to the subsequent drilling obligations of Section 10 of the unit agreement, a Plan of Development is required to be filed yearly.

Approval of this agreement does not warrant or certify that the operator thereof and other holders of operating rights hold legal or equitable title to those rights in the subject leases which are committed hereto.
