STATEMENT OF THE CASE

Milestone seeks an order approving its proposed Beaza SWD No. 1 well, which will have a surface location in Unit H in Section 25, Township 24 South, Range 34 East, NMPM, in Lea County. Milestone requests authorization to inject produced water into the well for disposal in the Bell and Cherry Canyon intervals of the Delaware Mountain Group at a depth of 5,497 to 7,240 feet. Milestone further requests that the Division approve a maximum injection pressure of 1,100 psi.
