STATEMENT OF THE CASE

Ridge Runner seeks an order pooling all uncommitted mineral interests in the Bone Spring formation in a 640-acre standard horizontal spacing unit comprised of the W/2 of Section 35, Township 22 South, Range 28 East, and the W/2 of Section 2, Township 23 South, Range 28 East, in Eddy County. Ridge Runner proposes to dedicate the horizontal spacing unit to: (1) the Gladiator Fed Com 3502 B #1H well, which has a surface location in Unit D in Section 35 and a bottom hole location in Unit M in Section 2; and (2) the Gladiator Fed Com 3502 B #2H well, which has a surface location in Unit D in Section 35 and a bottom hole location in Unit N in Section 2. The completed intervals for the wells will be orthodox.


