

CASE NO. 13699: *In the matter of the hearing called by the Oil Conservation Division for an order creating and extending certain pools in Chaves and Eddy Counties, New Mexico.*

(a) CREATE a new pool in Eddy County, New Mexico for the production of gas from the Wolfcamp formation and designated as the Rio Penasco-Wolfcamp Gas Pool (**Pool Code 97512**). The discovery well is the Mack Energy Corporation Brazos State Well No. 1 (**API No. 30-015-34165**) located in Unit D of Section 18, Township 18 South, Range 24 East, NMPM. Said pool would comprise:
