#### STATEMENT OF THE CASE

Salt Creek's application seeks an order authorizing it to inject treated acid gas ("TAG") from the Amerdev South Gas Processing Plant into the Salt Creek AGI #1 well. The well will be located in Section 21, Township 26 South, Range 36 East in Lea County. Subject to the permit conditions agreed upon by the parties, Salt Creek requests authorization to inject TAG into the Bell Canyon and Cherry Canyon formations of the Delaware Mountain Group in an injection interval from 5,410 feet to 7,000 feet. Salt Creek further requests approval of a maximum daily injection rate of eight MMSCFD and a maximum surface injection pressure of approximately 2,149 psig.
