STATEMENT OF THE CASE

Mewbourne’s application seeks an order pooling all uncommitted mineral interests in the Wolfcamp formation in a 640-acre, more or less, standard horizontal spacing unit comprised of the E/2 of Section 28 and the E/2 of Section 21, Township 23 South, Range 28 East in Eddy County, New Mexico. Mewbourne proposes to dedicate the horizontal spacing unit to the following wells: (1) the Starship 28-21 W0OB Fee #1H well, which will be horizontally drilled from a surface location in Unit P in Section 28 to a bottom hole location in Unit B in Section 21; and (2) the Starship 28-21 W0OB Fee #2H well, which will be horizontally drilled from a surface location in Unit P in Section 28 to a bottom hole location in Unit B in Section 21. The completed intervals for the wells will be orthodox.




