**Item 5.** ***Case No. 20779: Application of Lucid Energy Delaware, LLC for authority to inject, Lea County, New Mexico.***

**Action:** Chair Sandoval stated that Case No. 20779 has been continued to the January 16, 2020 Commission Meeting.

**Item 6.** *Case No. 20780: Application of Salt Creek Midstream LLC for authorization to drill, complete and operate an Acid Gas Injection (AGI) well at the Ameredev South gas processing facility (the "Plant") in Lea County, New Mexico.*

**Action:** Chair Sandoval stated that Case No. 20780 has been continued to the December 11, 2019 Commission Meeting.

**Action:** There was no other business.


**Item 9. 2020 Meeting Discussion**
