2 11:01 a.m.:

3 CHAIRMAN FESMIRE: We're going to go on the
4 record in Cause Number 13,589.

5 MR. HISER: Mr. Carr --

6 CHAIRMAN FESMIRE: Yeah, is he out there? Since
7 we can't get folks interested in coming back, we're going
8 to go ahead and go back on the record in Cause Number
9 13,589, the Duke Application.

10 MR. CARR: Thank you, Mr. Chairman. You'll make
11 my weekend, what's left of it --

13 MR. CARR: -- whatever you do.

14 CHAIRMAN FESMIRE: Are we --

7 conditions, Duke's Application.

8 Let the record reflect that all three
9 Commissioners have signed the order, Order Number R-12,546,
10 in Case Number 13,589, and that said order has been
11 transmitted to the Secretary.

12 At this time we will go off the record in Case
13 Number 13,589 and back onto the record in Case Number
14 13,586.
