

**AFFIDAVIT**

I, Larry Eudy, Assistant Vice President and Trust Officer of Wells Fargo Bank, N.A. being first duly sworn upon my oath, state as follows:

1. I am over the age of twenty-one years and have personal knowledge of the facts contained in this Affidavit. The facts contained in this Affidavit are true and accurate.
  
2. Wells Fargo Bank, N.A. as Trustee of the Angela Leigh Simpson Starrett Management Trust u/a dated 9/9/99 (hereinafter "The Trust") owns an interest in the minerals located in the NE/4 NE/4 in Section 7, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico.
  
3. The Trust's predecessor in title, Sweetie J. Boyle, Individually & Independent Executrix of the Estate of R. E. Boyle, deceased, signed an oil and gas lease on July 8, 1981 covering the above described land in which Belco Production Corporation was original lessee. Bass Enterprises Production Company is the current lessee and has the right to develop the oil and gas minerals in which The Trust owns an interest.
  
4. As this is the only lease for minerals, The Trust remains an unleased interest owner of any potash minerals in said Section 7.
