(A) Create a new pool in Chaves County, New Mexico classified as a gas pool and designated as the Alkali Draw; Siluro-Devonian Gas Pool (**Pool Code 97284**). The discovery well, the Bobwhite 'BBH' Deep Federal Com. #1 (**API No. 30-005-62135**) completed by Yates Petroleum Corporation, is located in Unit D of Section 3, Township 6 South, Range 26 East, NMPM.
