**STATEMENT OF THE CASE**

**APPLICANT**

Applicant proposes to drill its Crooked Seams Well No. 2 to test the Basin-Fruitland Coal Gas Pool and Pictured Cliffs formation at an unorthodox gas well location 420 feet from the north line and 1090 feet from the East line (Unit A) of Section 14, Township 30 North, Range 12 West, NMPM.

OPPONENT

XTO Energy Inc. operates the well unit to the north of the proposed Crooked Seams Well No. 2, and objects to the unorthodox location because (i) there are orthodox locations available to drill the subject well, and (ii) drilling the well at the proposed location will adversely affect XTO Energy Inc.'s correlative rights.




